The Menarini Group is present in 140 countries around the world, with companies spanning Europe, Asia, Africa and the Middle East, Central America and the United States.

Thanks to the valuable contribution of over 17,000 employees, every year almost 600 million packs of drugs are produced at the Group's 18 manufacturing sites, including a biotech plant for the manufacturing of monoclonal antibodies that also serves external clients.

The Group has also decided to invest in the construction of a new production plant, with great attention paid to the environmental impact, looking for technological solutions that favour the recovery of natural resources and energy efficiency.

From research to manufacturing, from distribution to scientific information, Menarini's goal is to achieve excellence.
