



PRIVACY NOTICE FOR HEALTH CARE PROFESSIONAL

Dear Doctor / Health Care Professional,

Menarini takes privacy very seriously and has taken measures to protect your personal information in compliance with all applicable laws. For this reason, we wish to provide up-to-date information as to how A. Menarini India Private Limited and its group companies (hereinafter the “**Company**”, “**us**” or “**we**”) processes your personal data and ensures compliance with the applicable laws.

1. What we can do with your Personal Data

2. What Personal Data we collect

The Personal Data which we may process are the following: (1) title; (2) name; (3) surname; (4) Gender (5) professional mobile phone number; (6) email address; (7) visit address (street, number, city, county, as well as email address and details of any other digital account); (8) job position (9) specialization i.e. plastic surgeon, cosmetologist, etc. (10) visit timing (11) data pertaining to the use and/or viewing, on your part, of our electronic/digital informational materials (i.e. email addresses); (12) other information pertaining the profession and preferences with regards to the services we offer.

3. How we process your Personal Data.

Personal Data are processed both in paper and/or electronically and entered into the company system in line with the applicable laws and regulations – including the aspects pertaining to data security and confidentiality - and in line with the best practices of fair and lawful processing.

We or our authorized service providers process your Personal Data for storing, analysing, processing, profiling and retain within and outside India sending you updates and information including but not limited to marketing initiatives, conference, scientific engagements, promotional materials, events, link to websites, respond to your requests for information about products and conducting business. We may store your data even after the end of our activities towards you, but only for as long as necessary to fulfil contractual and legal obligations as well as to fulfil the purposes listed above. We update and maintain our databases so as to ensure your Personal Data is always correct and accurate.

We make sure that Personal Data is transferred abroad in line with the applicable laws and regulations, and that appropriate contractual and security safeguards are in place.
